

PRIVACY NOTICE CONCERNING THE PROCESSING OF PERSONAL DATA PROVIDED IN CONTRACTS

Purpose of processing	Keeping contact while making a bid, entering into a contract or fulfillment of a contract, exercise rights and perform obligations deriving from the contract. Furthermore, the name, telephone number and address of the contact persons designated in the agreement on commercial activities are processed in order to secure that the POS terminals provided by the Controller's partner, FestiPay Zrt., are delivered to the persons entitled to receive them, to prevent the misuses of them.
Duration of processing	The Controller deletes the personal data after 5 years following the failure of entering a contract or the termination of a contract except for a legal dispute, in an event of which, the personal data will be deleted after the final end of the legal dispute or the enforcement proceedings.
Legal basis for processing	<p>Legitimate interest of the Controller pursuant to Article 6 (1) f) of the GDPR.</p> <p>The legitimate interest of the Controller is to</p>

	keep contact during entering into and performing the contract and to exercise rights, perform obligations deriving from the contract.
Transfer	
<p>Personal data are processed by the employees of the Controller in order to achieve the abovementioned purpose.</p> <p>The name, telephone number and address of the contact persons designated in the agreement on commercial activities are transferred to FestiPay Zrt.</p> <p>No personal data will be transferred to third countries or to international organisations.</p>	
Rights, legal remedies, complaints	
<p>Pursuant to the GDPR, during the data processing, you may request access to the personal data and may request information about data processing (which will be provided by the Controller within no more than 1 month), may request rectification of personal data or the restriction of data processing, and you have the right to object.</p> <p>If you feel that the Controller has violated any of the legal provisions applicable to data processing, please contact the Controller first, using any of the above contact information, or at the following email address: adat@nagyonbalaton.hu.
